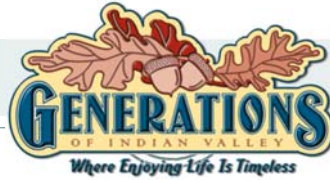

They can provide up to date information on tax filing requirements and deadlines if they end up changing • Filing of IRS 1040-SR, 1040 and PA and Local Tax Returns (tax preparation fees do apply based on the complexity of the return) • Filing of Federal, State and Local Application for Automatic Extension of Time to File , if needed • They will work with you given the current conditions and restrictions to exchange paperwork as needed. While there is no allowable mechanism in place that permits file by phone to file the tax return, they do have alternative capabilities to file electronically and exchange documents securely or via the US mail. • Fees may apply for services.
